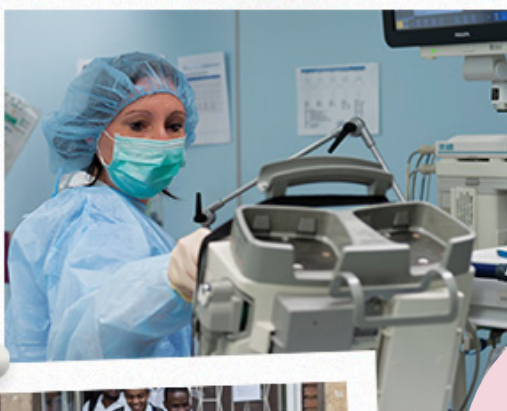

Elizabeth Adams je predsednica Evropske federacije združenj medicinskih sester in zastopa tri milijone medicinskih sester po Evropi. Trenutno je vodja službe za politiko varnosti in zagovorništva pacientov pri Nacionalnem uradu za varnost pacientov na Ministrstvu za zdravje Severne Irske. Je članica upravnega odbora globalne kampanje Nursing Now, ustanovljene na podlagi poročila The Triple Impact of Nursing. Njeno mednarodno delovanje vključuje tudi članstvo v številnih mednarodnih skupinah, kot sta Koalicija za varovanje zdravja na vojnih območjih in Mednarodni center za migracije medicinskih sester. Poleg tega je izredna profesorica na Univerzi za tehnologijo Curtin, Zahodna Avstralija in University College Dublin, častna članica Fakultete za zdravstveno nego in babištvo Royal College of Surgeons Ireland.

*Elizabeth Adams is currently the Patient Safety and Advocacy Policy Officer, National Patient Safety Office in the Department of Health. She has been recently appointed Adjunct Faculty, Dublin City University. She is President of the European Federation of Nurse Associations and represents 3 million nurses across Europe. She is a Board member of the global Campaign Nursing Now, based on the report The Triple Impact of Nursing (UK All-Party Parliamentary Group on Global Health). Her international representation includes membership of numerous global groups, including, for example, Safeguarding Health in Conflict Coalition and International Centre of Nurse Migration. In addition, she is Adjunct Associate Professor with Curtin University of Technology, Western Australia and University College Dublin, Honorary Fellow Faculty of Nursing and Midwifery Royal College of Surgeons Ireland.*

# The potential impact of midwives on lives saved, and what this means for the future of midwifery

Fran McConville je babica in medicinska sestra z magisterijem iz zoologije in doktoratom iz ekonomije v zdravstvu. Potem ko je bila sredi 80. let prejšnjega stoletja v Bangladešu kot volonterska babica, se je večino kariere ukvarjala s področjem spolnega, reproduktivnega zdravja in zdravja žensk in otrok v Jugovzhodni Aziji, Afriki in na Bližnjem vzhodu. Kot svetovalka je sodelovala z vrsto agencij, nevladnimi organizacijami in Združenimi narodi.

Fran je trenutno svetovalka za babištvo pri Svetovni zdravstveni organizaciji s sedežem v Ženevi in zagotavlja tehnično in organizacijsko podporo 194 državam članicam. Je vneta zagovornica pravic žensk, novorojenčkov in njihovih družin ter dostopa do kakovostne babiške obravnave za vse. Skrbi za to, da zagotovljena babiška obravnava ne temelji le na obstoječih dokazih, temveč tudi na znanju.

*Fran McConville qualified as a midwife and a nurse, has a BSc in Zoology and an MSc in Health Economics. After being a VSO midwife in Bangladesh in the mid-1980's, Fran spent much of her career in sexual, reproductive, maternal and newborn health and gender in South East Asia, Africa and the Middle East, working with a range of NGO's and UN agencies and as a Health Adviser to the UK department of international development (DFID).*

*Fran is currently the Midwifery Adviser to the World Health Organization, based in Geneva, providing technical and policy support to the 194 Member States. She is passionate about the rights of women, newborns and their families to have access to quality midwifery care everywhere, and ensuring that the care provided is based not only on existing evidence but on knowledge that challenges assumptions and arises from asking different questions.*

# Državljeni zaupajo medicinskim sestram, kaj pa zdravstvena politika?

Prof. dr. Brigita Skela Savič, znanstvena svetnica, je visokošolska učiteljica in raziskovalka na FZAB od njene ustanovitve, od 2006 do 2017 tudi dekanja fakultete. Na FZAB je nosilka predmetov na področju raziskovalnih metod, na dokazih podprtega dela in menedžmenta v zdravstvu na vseh treh bolonjskih stopnjah. Habilitirana je na FZAB in Univerzi na Primorskem. Je raziskovalka zdravstvenega menedžmenta, dolgožive družbe, promocije zdravja, elementov profesionalizacije zdravstvene nege in drugih zdravstvenih strok. Ima bogat opus znanstvenih objav v mednarodnih in domačih revijah in bogate izkušnje z vodenjem in sodelovanjem v mednarodnih in nacionalnih raziskovalnih projektih. Na FZAB vodi Katedro za zdravstvene vede. Na Medicinski fakulteti Univerze v Ljubljani je nosilka izbirnega predmeta na doktorskem študiju. Mednarodno deluje kot raziskovalka in vabljen strokovnjakinja v razvojne in raziskovalne projekte na področju izobraževanja in razvoja zdravstvene nege. Od 2013 do 2018 je bila glavna in odgovorna urednica Obzornika zdravstvene nege, je članica uredniškega odbora revij Zdravstveno varstvo, Obzornika zdravstvene nege in Nurse Education Today. Za obdobje 2017 do 2021 je izvoljena v svet direktorjev Mednarodnega sveta medicinskih sester, ICN zastopa v organizaciji Global Coalition on Aging. Je družbeno aktivna državljanka, zagovornica dostopne in kakovostne zdravstvene obravnave za vse državljane.

*Brigita Skela-Savič is a full professor in research and evidence-based practice in health care at Angela Boškin Faculty of Health Care (ABFHC) in Slovenia. She is Head of Chair for Health Care Sciences and Head of Institute Angele Boškin for research's in Health Care Sciences. She served as the Faculty Dean from 2006 to 2017 and she was the first dean of nursing faculty with background in nursing in Slovenia.*

*At the ABFHC, she teaches research methodology, evidence-based practice in healthcare, and healthcare management, mostly on master and PhD level. At the Faculty of Medicine, University of Ljubljana, she teaches an elective course evidence-based practice in nursing as a part of the doctoral study program Public health.*

*In the international arena, she participates in development and research projects in the areas of education and nursing development as a researcher and an invited expert in nursing education Bosnia and Herzegovina and in Kyrgyzstan. In 2020, she started serving as an alternate member of the Medical Ethics Committee of the Republic of Slovenia. She was elected to serve on the ICN (International Council of Nurses) Board of Directors for the term 2017-2021, representing the ICN in the Global Coalition on Aging. From 2013 to 2018, she was the Editor-in-Chief and Managing Editor of the Slovenian Nursing Review. She is a member of the editorial board for the Slovenian Journal of Public Health, the Slovenian Nursing Review, and Nurse Education Today.*

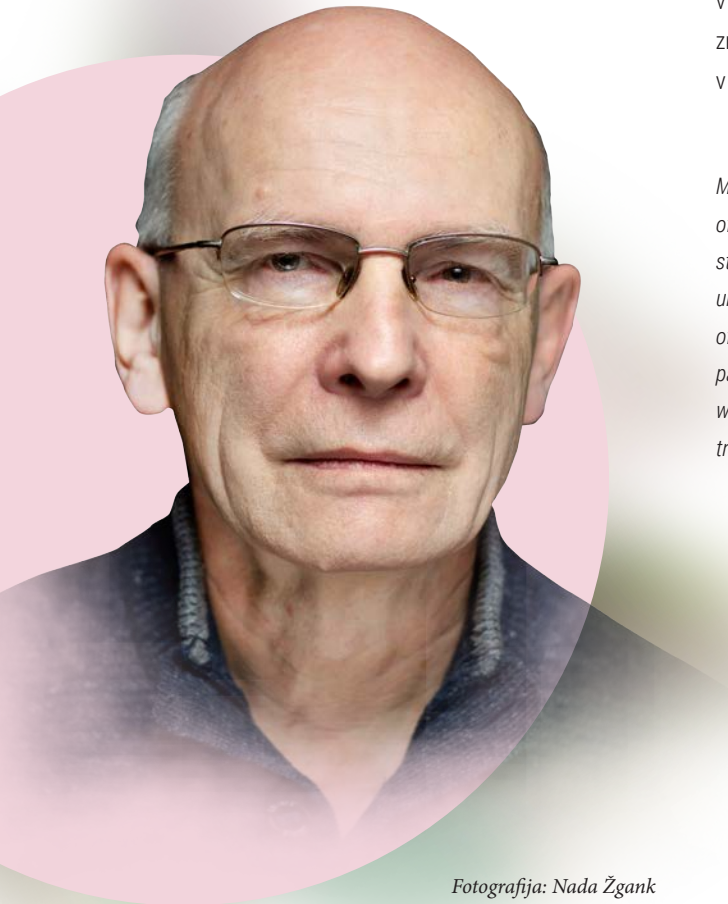

# Pandemija in solidarnost

Mladen Dolar je profesor in znanstveni svetnik na Oddelku za filozofijo Filozofske fakultete Univerze v Ljubljani. Njegova glavna raziskovalna področja so nemški idealizem, strukturalizem in psihoanaliza ter filozofija umetnosti. Predaval je na številnih univerzah v Evropi in Ameriki (redno je gostujoči profesor na univerzi v Čikagu in na European Graduate School v Švici). Poleg skoraj 200 razprav in člankov v znanstvenih revijah in zbornikih je avtor 14 knjig v slovenščini, v tujini pa je najbolj znana njegova knjiga o glasu *A Voice and Nothing More* (MIT 2006), ki je bila prevedena v deset jezikov.

*Mladen Dolar is Professor and Senior Researcher at the Department of Philosophy, Faculty of Arts, University of Ljubljana. His principal areas of research are German idealism, structuralism and psychoanalysis, and philosophy of art. He has lectured extensively at universities across Europe and in the USA (he is a regular Visiting Professor at the University of Chicago and at the European Graduate School in Switzerland). Apart from nearly 200 papers in scholarly journals and collective volumes he published fourteen books in Slovene, while his most notable book publication abroad is *A Voice and Nothing More* (MIT 2006), translated into ten languages.*

# Živimo na planetu, ki ne raste

Diplomirala je leta 1980 na Fakulteti za naravoslovje in tehnologijo v Ljubljani in doktorirala na Biotehniški fakulteti. Je redna profesorica na Biotehniški fakulteti, predstojnica Katedre za agrometeorologijo in članica Medvladnega foruma za podnebne spremembe (IPCC) v Ženevi. V Sloveniji velja za eno izmed pionirk pri raziskovanju vpliva podnebnih sprememb, predvsem njihovega vpliva na rast in kmetijsko pridelavo. Problematiko aktivno predstavlja tudi s poljudnimi objavami. Leta 1988 je s soavtorjem prejela nagrado Sklada Borisa Kidriča za originalne prispevke k dinamičnemu modeliranju produkcijske organske mase v odvisnosti od okolja v lokaciji in širšem prostoru. Znotraj Medvladnega odbora za podnebne spremembe Združenih narodov (IPCC) je kot članica opravljala veliko različnih funkcij. Leta 2007 je IPCC za prizadevanje pri ozaveščanju javnosti o usodnih posledicah segrevanja ozračja prejel Nobelovo nagrado za mir in z njim je tudi Lučka Kajfež Bogataj postala soprejemnica te prestižne nagrade. Leta 2008 je prejela red za zasluge za odmevno znanstveno delo na področju proučevanja podnebnih sprememb ter njeno predanost varovanju okolja.

*Lučka Kajfež Bogataj graduated in 1980 from the Faculty of Natural Sciences and Engineering in Ljubljana and obtained her PhD from the Biotechnical Faculty where she is today a Full Professor and Chair of Agrometeorology as well as a member of the Intragovernmental Panel on Climate Change (IPCC) in Genève. In Slovenia she is recognised as one of the pioneers of researching the impact of climate change, especially on growth and farming. She has been publicly drawing attention to the issue by publishing articles for the popular audience. In 1988 she and her co-author received the Boris Kidrič Fund Award for an original contribution to dynamic modelling of production organic mass in relation to the environment in the location and wider space. As a member of the Intragovernmental Panel on Climate Change (IPCC) she has served in various roles. In 2007 the IPCC received a Nobel Peace Prize for raising awareness of the public on the detrimental consequences of global warming, thus becoming a joint recipient of the Prize. In 2008 she received the Order of Merit for her far-reaching scientific work in climate change and her dedication to environmental protection.*

# Skozi trnje do cvetlice

Slovenska znanstvenica Polona Šafarič Tepeš, ki raziskuje v New Yorku, se posveča razumevanju redkih rakov, vodenih preko fuzijskih onkoproteinov. Od nekdaj je sprejela sleherno priložnost za razumevanje znanosti: od biološko usmerjene gimnazije do doktorata na Fakulteti za farmacijo. 2015 je ustanovila sodelovanje med Cold Spring Harbor Laboratorijem (CSHL) v New Yorku, domu osmih Nobelovih nagradencev, in Fakulteto za farmacijo ter istega leta začela svojo doktorsko izmenjavo. Na CSHL je razvila in vitro model mezenhimskega hondrosarkoma, vodenega preko HEY1-NCOA2 fuzije in predklinični in vivo model, ter našla uspešno tarčno terapijo. Ti rezultati so jo pripeljali do sodelovanja s sarkomskim strokovnjakom prof. dr. med. Robertom Makijem, FACP, FASCO, ki vodi multicentrično klinično študijo z omenjeno tarčno terapijo. Na podlagi njenih rezultatov so začeli novačiti paciente z mezenhimskim hondrosarkomom po ZDA v 2020. Življenjska izkušnja v temperamentnem New Yorku ji je odprla oči o marsikaterih težavah, ki jim prej ni bila neposredno izpostavljena. Problematika žensk v znanosti in zdravstvu je postal njen »projekt v prostem času«. Vzpostavila je sodelovanje s slovensko veleposlanico Združenih narodov, zaveznico žensk v znanosti, s katero sta organizirali uraden obisk 12 veleposlanikov ZN v CSHL. 2020 in 2021 je bila povabljen panelistka na konferenci Združenih narodov, organizirane preko kraljevske akademije Royal Academy of Science International Trust (RASIT) na mednarodni dan žensk in deklic v znanosti. 2021 je postala znanstvena sodelavka kraljevske akademije RASIT, kjer pomaga pri ustvarjanju dogodkov ZN z namenom povezovanja strokovnjakov ter ambasadorjev na temo različnih znanstvenih problematik, vključno s spolno enakopravnostjo. Poleg tega je članica slovenskega društva VTIS, kjer je letos soustvarila klub Slovenk po svetu z namenom povezovanja in medsebojnega sodelovanja uspešnih Slovenk.

*A Slovenian-born, New York-based scientist, Polona Safaric Tepes is investigating fusion-driven cancers to find an effective treatment for rare type pediatric cancers. She always enjoyed learning about science and biology didn't allow any science program or school to slip away from a science-oriented high school to a Ph.D. program. She established a collaboration between world-renown Cold Spring Harbor Laboratory (CSHL) NY, home to eight Nobel Prize laureates, and the Faculty of Pharmacy at the University of Ljubljana, Slovenia, where she is currently enrolled in Ph.D. She has been working at the CSHL, NY for over 5 years where she developed a new blueprint to study under-researched rare tumors, driven by fusion oncogenes, such as mesenchymal chondrosarcoma. She also developed a preclinical model of this disease and found an effective treatment which led her to collaborate with leading sarcoma expert, dr. Robert Maki, MD, Ph.D., to enroll the patients with mesenchymal chondrosarcoma in a USA-wide clinical trial with a new targeted therapy. In 2019 she became involved through the Slovenian mission to the United Nation (UN) in calls for action on gender equality, and she was an invited speaker at the conference on the International Day of Women and Girls in STEM at the UN in 2020 and 2021, to address the gender gap issues in science and healthcare. Since then she became an active member of the Royal Academy of Science International Trust, the organizer of gender equality events at the UN, where she moves forward to address the issues of women in STEM globally. However, she is eager to contribute the awareness for gender equality in her mother-country, Slovenia. Through the Association of Slovenes Educated Abroad (Društvo VTIS) she co-founded the Slovenian Women Abroad club, to help bridge the gender inequality gap also in Slovenian academy and healthcare, where she is currently involved in helping to write a White Paper for Slovenian Research and Innovation Strategy 2021-2030.*

# Dinamično zdravstvo v rigidnih zdravstvenih sistemih

Petra Došenović Bonča je izredna profesorica na Ekonomski fakulteti Univerze v Ljubljani. Njeni raziskovalni področji sta ekonomika javnega sektorja in ekonomika zdravstva. Na slednje posega tudi njena doktorska disertacija iz leta 2011 z naslovom Inovacije kot dejavnik učinkovitosti in uspešnosti bolnišnic v Sloveniji. Petra Došenović Bonča je članica sosveta za zdravje Statističnega urada Republike Slovenije. Je članica znanstvene organizacije The Operational Research Society. V obdobju 2013–2017 je bila na Ekonomski fakulteti koordinator mednarodne akreditacije poslovnih šol EQUUS. Objavila je članke, v katerih analizira in proučuje različne vidike slovenskega zdravstvenega sistema in reforme ter politike v tem sektorju. Sodeluje v svetovalnih projektih na področju zdravstva v Sloveniji. Na Ekonomski fakulteti je aktivno sodelovala pri razvoju magistrskega študija Management in ekonomika v zdravstvenem varstvu. Od leta 2017 je tudi vodja tega programa, predava pa pri predmetih Osnove ekonomike zdravstvenega varstva, Ekonomske analize v zdravstvu, Zdravstveno zavarovanje ter Zdravstvo in zdravstveni sistemi.

*Petra Došenović Bonča is an associate professor at the Faculty of Economics, University of Ljubljana. Her research areas are public economics and health economics. Her doctorate thesis from 2011 titled "Innovations as determinants of hospital efficiency and performance" also dealt with these areas of research. She is currently a member of the Statistical Advisory Committee for Health at the Statistical Office of the Republic of Slovenia. She is also a member of the Operational Research Society. In the 2013–2017 period, she was the coordinator of the international accreditation of business schools EQUUS at the Faculty of Economics. She has published several academic articles analysing and evaluating Slovenia's health care system as well as policy initiatives related to this sector.
